

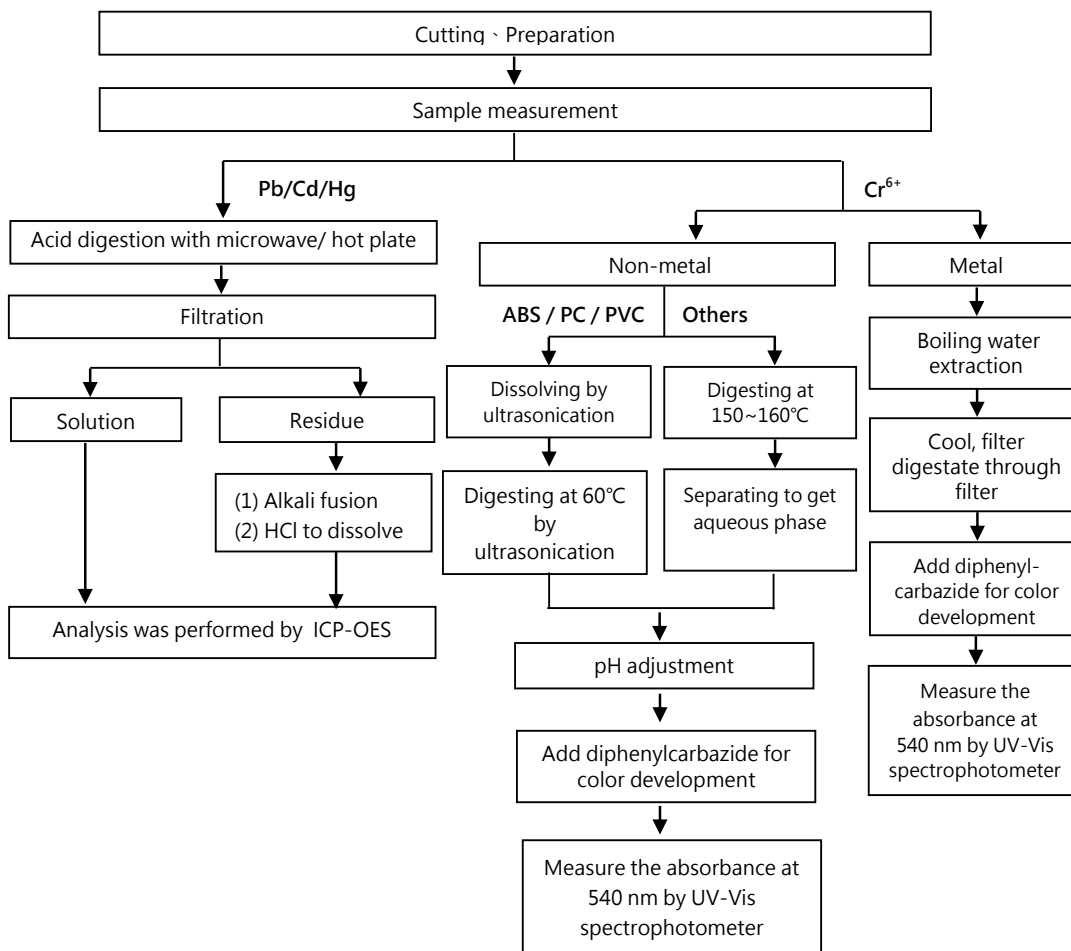

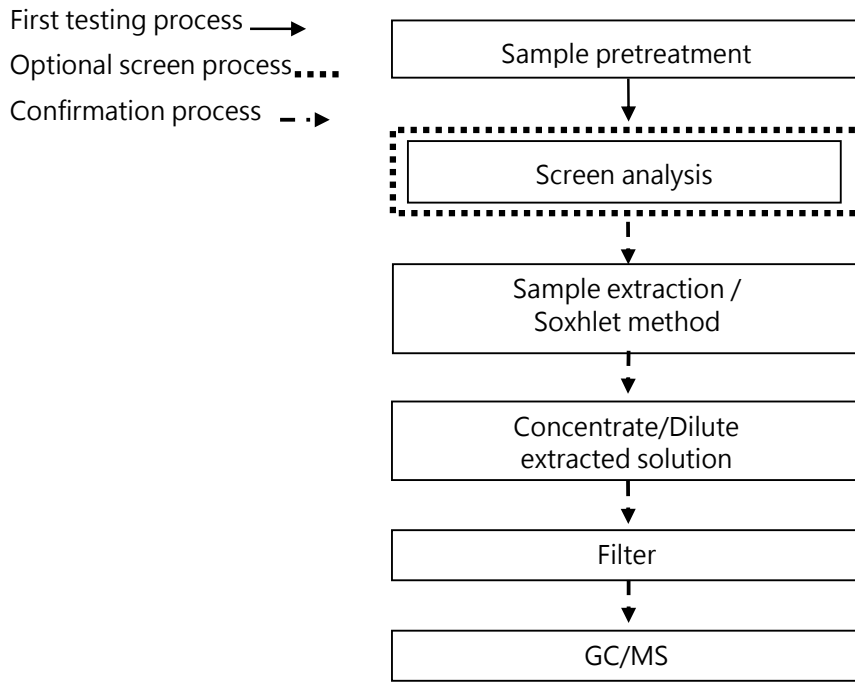

### Analytical flow chart – PBBs / PBDEs



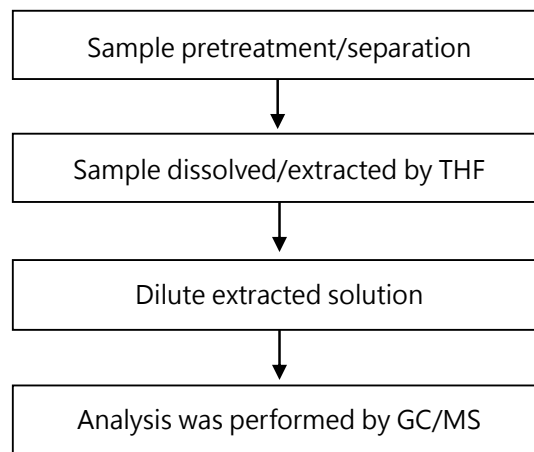

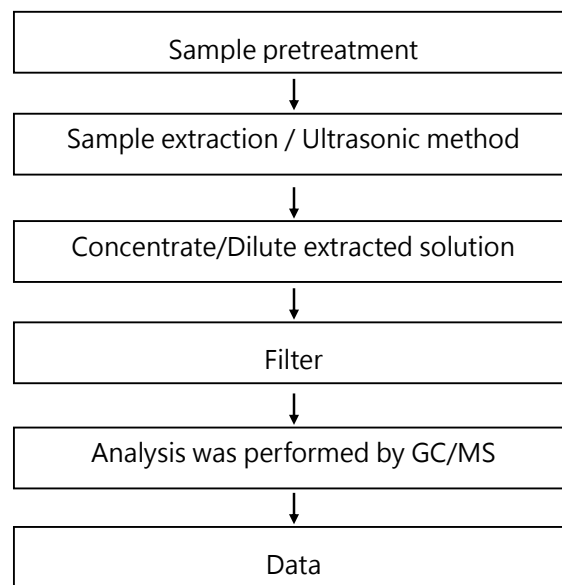

### Analytical flow chart - HBCDD



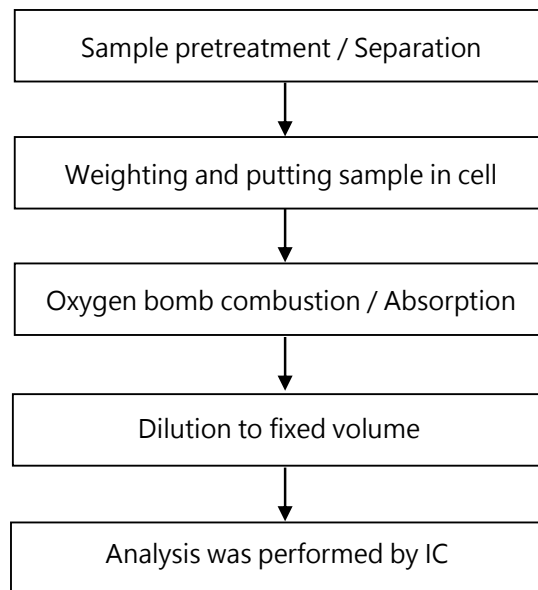

### Analytical flow chart - Halogen

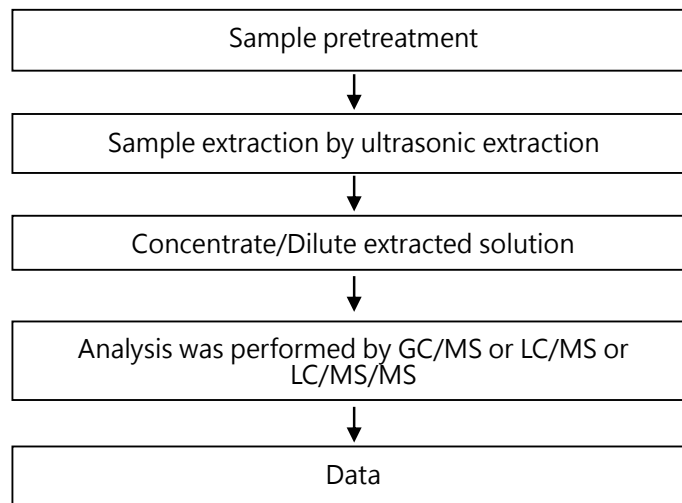

Analytical flow chart – PFAS (including PFOA/PFOS/its related compound, etc.)

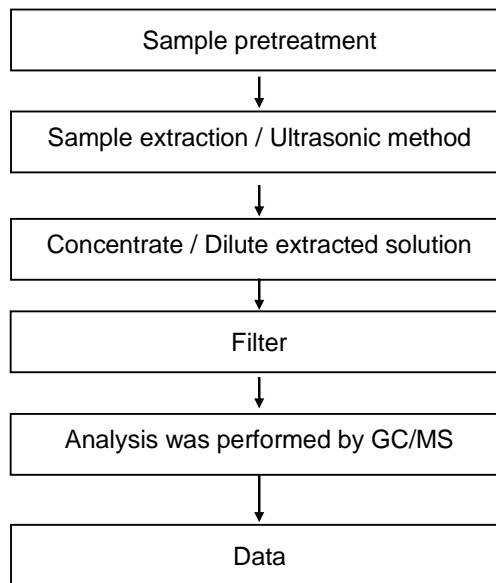

### Analytical flow chart - Dimethyl Fumarate

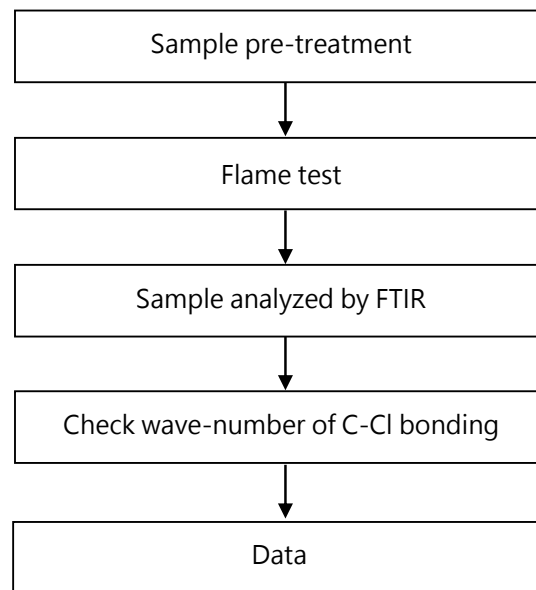

### Analysis flow chart - PVC

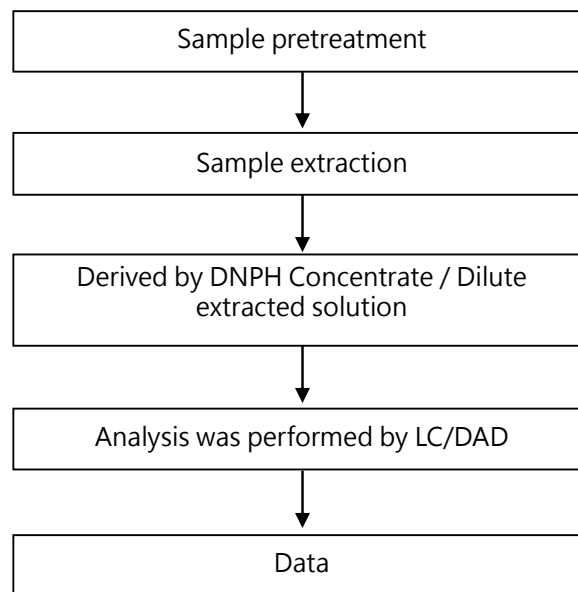

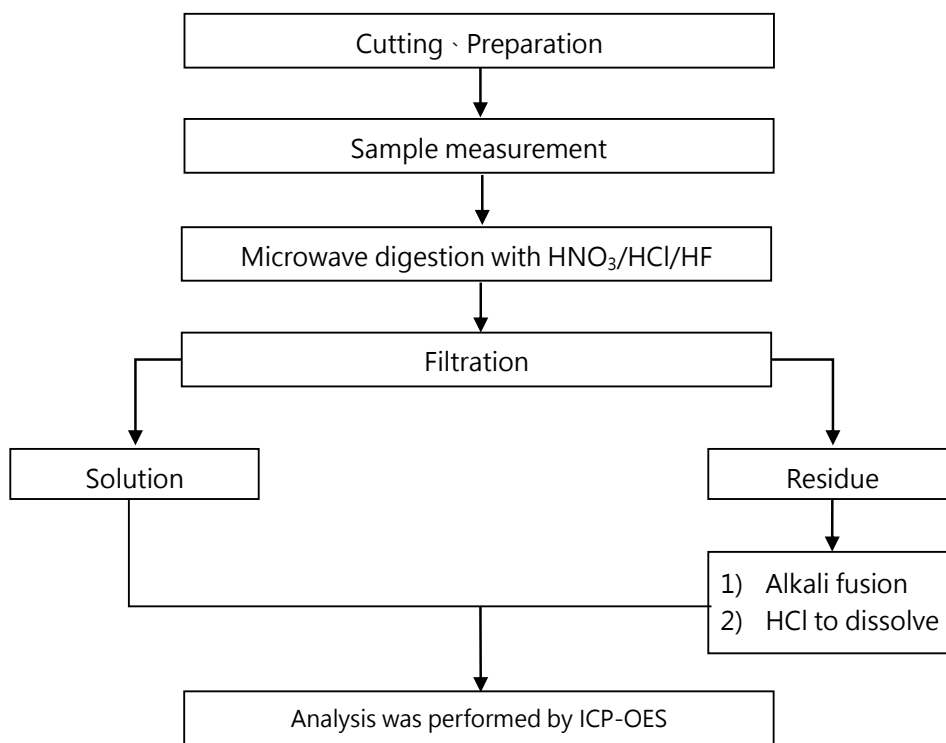
